Summary

The purpose of this leaflet is to specify the country codes to be used by UIC and OSJD members for the international exchange of data.

1 - Purpose of the leaflet

The purpose of this leaflet is to specify the country codes to be used by UIC and OSJD members for the international exchange of data.

The country code (hereinafter also referred to as "code") refers to the two-position numerical codes described below used to identify a country (State).

These codes are published by UIC Headquarters and the OSJD Committee (hereinafter referred to as "UIC" and "OSJD") (see point 4 - page 5).

2 - Coding structure

The standard numerical country codes are two-position numerical codes running from 01 to 99.

Only one code may be allocated per country (State).

The same code may be allocated to several countries in different continents. In the case of a conflict, differentiation is made by a 3rd position, the continent identification:

- 1 Europe-Asia
- 2 Africa
- 3 America
- 4 Australia

The list of codes may be consulted or copied from the UIC and OSJD websites at any time.

3 - Code administration

UIC and OSJD shall be responsible for administering the codes.

4 - Management of the leaflet and the code list

The Joint UIC/OSJD Group for Coding and Information Technology shall be responsible for managing this leaflet and the code list published on the websites of the UIC and OSJD.
